NOTE: A motion was passed June 2018 that the area meeting goes for 1.5 hours but be extended at the Chairman's discretion if there are pressing items to be discussed.

General Business:

- Guest Gabrielle (Area G Delegate) speaking on combining CSO and Area Assemblies in Area G.
 - Gabrielle outlined how the idea of combining both was born. It started with Gabrielle having a PI idea which took months as she went between each quarterly held assembly to gain endorsement and funding. The CSO and Area Assemblies were held at different times and as discussions on the idea progressed it needed to bounce between the 2. It was very fractured.
 - After 1 year trial of having the combined assemblies it was voted to continue as it was deemed very successful. There was a significant increase in the GSRs/CSRs attending the assemblies.
 - Area and CSO Treasuries and management/steering committees remain separate.
 - The schedule is 4 quarterly combined assemblies plus one Area-only assembly meeting for reviewing Topics for Conference; they don't have a separate AGM.
 - One initial difficulty they had was the first meeting went on for quite a long time.
 - O Anna highlighted her experience of visiting one of the combined assemblies in Area G. It was 2 separate entities meeting at one place communicating. People who did not get money for their project were ok with it as they heard the other ideas that did obtain funding. Everyone meeting together also gave a clear picture of availability of funds, where they were going and what could be in the pipeline. It seemed to be very effective as the 2 arms of service worked collaboratively together.
 - Having a combined assembly also allowed groups to send just one person to represent both the CSR and GSR at the one assembly. This has increased engagement with / participation by the groups; few were sending a representative to the separate Area and CSO meetings.

- Susan shared that she feels enthusiastic about what is being proposed, that it would create higher engagement and likes the idea of the option for groups to elect a combined CSR and GSR. 12th Step work is the common ground for Area and CSO to cooperate on and would be a good place to begin.
- Mark spoke to the need to conduct CSO business in accordance with the responsibilities entrusted to the CSO officers.
- The idea of exploring this further was ENDORSED by the GSRs but it was highlighted to move forward gently. We might explore drafting a proposal for the AGMs that might be considered at the CSO AGM and the Area AGM.
- The chair thanked our guests on behalf of all assembled for contributing to the engaging and lively dialogue in consideration of further NSCSO and Area E cooperation.

Public Information for shopping centres and cinemas (Michael S):

AREA E Committee Reports

Thank you to all who attended our all-members assembly on Saturday 27 October. We had 5 GSRs represented + Committee members + good representation from RtR. I think all would agree that the discussion was informative and positive.

Gabriellele N, the delegate from Area G, has agreed to attend our November meeting to share about her experience of combined assemblies (CSO + Area). Hopefully we'll be able to get our GSR's questions answered to the point that we might engage with NSCSO to gauge their interest. I've also invited the NSCSO Office Manager, Susan, and whomever might like to come from the NSCSO Committee, albeit with short notice.

I'll include my observations from the Area G combined assembly that Anna and I attended in August here:

There are approximately 25 people sitting in an large oval, which is nearly as big as the room allows. The assembly opens with a reading of the long form of the Traditions, each in turn going around the room, followed by Concepts 10, 11, and 12. GSRs, Area and CSO Committee, and Subcommittee reps are spread throughout the circle.

Area G has an active PI Committee with its own Group Representatives. Some groups also have a Treatment Rep. Certain groups or individuals look after the H&I activity at individual facilities; the connection/relationship to CSO/Area is maintained by the semi-annual literature donation that they make available.

The Area G Treasurer and the CSO Office Manager report on their annual operating cost budget and the prudent reserve suggested at 10-12 months of operating costs. There are about 20 groups in the area making regular donations to the Area G CSO, most using the 60/30/10 plan.

The atmosphere is collaborative. As agenda items come up, ascent is largely by a "sense of the room" as described in the service manual, or by agreement of those present. As matters arise and are agreed that need funding, such as deposits for a sober New Year's event and a project to develop/adapt literature for specific audiences, the discussion is clear and open about how much money is in the CSO treasury and the Area treasury, and how the cost will be covered. Discussion is constructive and acknowledges the financial constraints not being able to fund all activities at once, maintaining respect for previous commitments agreed.

I'm interested to know whether Area E groups, Area E committee members, and NSCSO committee members are interested in exploring the combined assembly model with the aim of increasing engagement with the groups. Area G reports an increase in active participation from about 10% to over 25% of groups in their area.
